SUPPLEMENTARY REGULATIONS

1. The course is closed. Anyone found riding or walking on the course will be disqualified for both days.
2. The rider's and minder's bike must pass technical inspection, all riders/minders must have a wrist band to pass inspection.
3. No spectator riding is allowed.
4. We have received special permission during the event to travel on State Park dirt roads and the rider's speed is limited to 25 MPH. (Speed checked by Department of Environmental Management officers)
5. Awards will be given out each day 15 min after the cut-off time. Riders must be present for award ceremonies.
6. All riders/minders must wear a helmet anytime they are riding their motorcycle. This includes to/from practice area, in the pits, or anywhere else.
7. There will be a Land use charge of \$20 for all riders and guests and an admission fee for spectators..
8. Food will be available in the Pits during the event.
9. Gates close Monday 6/21 @ Noon
10. There is no "Clubman" class or lines at this event

From Interstate 95(N): Take Exit 5A (Rt 102 S). Bear right onto Route 3 South (1/3 mi). Turn right on Route 165 (3 mi) to Escoheag Hill Rd (5 mi). Turn right and follow arrows approximately 1.5 mile to Stepping Stone Ranch.

From Interstate 95(S): Take Exit 5B (Rt 102 S). Bear right onto Route 3 South (1/3 mi). Turn right on Route 165 (3 mi) to Escoheag Hill Rd (5 mi). Turn right and follow arrows approximately 1.5 mile to Stepping Stone Ranch.

From Interstate 395: Take Exit for Route 138 (Voluntown). Follow Route 138 East onto Route 165. Follow Route 165 past Beach Pond. Turn left onto Escoheag Hill Road and follow for 1.5 miles to Stepping Stone Ranch.

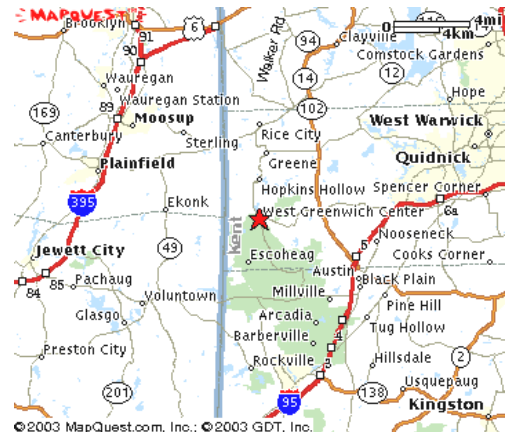
